REPORT FROM SHELLY MASI, PARTNER, AND IRENE CRASTO, MANAGER, KPMG

In response to a question regarding four instances of non-timely removal of terminated employees from IT access, University Controller Barry Kaufman stated that in most instances these are people that would have had access only at their office. There is certainly no indication of a security breach or anything like that.

In response to a question regarding continuing recommendations, Shelly Masi of KPMG stated that when the audit reports indicate a continuing recommendation, it is because the finding was cited in the prior year as a comment and was noted again because it was not completely resolved by the college. Within the comment KPMG asks that the college management respond and provide a status and their progress to it. In most cases the response does say what they have done to date. This is also reviewed by the University Controller's Office.

In response to several question regarding reported findings, Shelly Masi of KPMG stated that on the A-133 audit the determination of a significant deficiency depends on the number of findings in one particular area, not the dollar amount. The number of findings that constitutes a significant deficiency depends in part on the number that you are sampling.

C. 2011 Engagement Letter (KPMG)

REPORT FROM SHELLY MASI, PARTNER, AND IRENE CRASTO, MANAGER, KPMG

In response to a question on financial statements, University Controller Barry Kaufman stated that KPMG does not audit individual college financial statements.

Shelly Masi of KPMG added that that would require auditing at a different materiality level.

In response to a question regarding auditing of fraud risks, Shelly Masi of KPMG stated that the auditing standard used is CS-99, which required for all financial statement audits public and non-public.
